Michael Bridges -

Michael Bridges is a 27-year resident of Farmington Hills. He was first elected in 2008 and was reelected in 2009, 2013, 2017 and 2021. Michael served as mayor pro tem in 2010, 2016 and 2023. He is the Council liaison to the Farmington Area Commission on Aging and the Economic Development Corporation and is a board member for the Heritage Hills Homeowner Association.



Michael is running for reelection to ensure that Farmington Hills remains a premier city for all its residents, and an attractive city for new families and businesses.

A 28-year resident of Farmington/Farmington Hills, Angie has been deeply involved in volunteer efforts, supporting bond and millage campaigns, serving as a PTA member, band booster, and participant in the Multicultural Multiracial Community Council. She currently serves on the Citizens Police Advisory Committee and has worked closely with three police chiefs.

Angie studied mortuary science at Wayne County Community College and Wayne State University, with a minor in music. She is also a licensed minister and former Miss Michigan USA contestant. She made history as the first African American PTA council president in the district and co-organized the community's first Martin Luther King Jr. Day celebration.

Her service includes donating annually to special education programs, providing food to families in need, and helping students cover graduation expenses. She has received the Master Boardmember Award, the African American Leadership Award in Education, and the CPAC Certificate of Graduation.

Angie currently serves on the executive boards of the Farmington/Farmington Hills Democratic Club and the 11th Congressional District Democrats. Now, she is running for Farmington Hills City Council to strengthen partnerships between schools, City departments, public safety agencies and the broader community.

Charlie Starkman

Charlie Starkman is a candidate for Farmington Hills City Council. He serves as the assistant director at the University of Michigan-Dearborn Counseling and Psychological Services Office and is the assistant director of Disability and Accessibility Services. He earned his bachelor's degree from the University of Michigan and his doctorate in clinical

PROPOSALS

City of Farmington Hills Charter Amendment Public Safety Millage

Shall Section 7.02c of the Farmington Hills City Charter be amended to allow a renewal of the previous voter-approved additional special tax rate for purposes of the public safety functions of the Fire and Police Departments by authorizing the City to levy a millage in the amount of 1.4764 mills (being \$1.48 per \$1,000 of taxable value) for ten years, starting with the July 2026 levy (resulting in the authorization to collect an estimated \$7,269,000 in the first year if approved and levied), which taxes are to be used only for purposes of fire and police staffing and equipment?

Clarenceville School District Operating Millage Proposition Exempting Principal Residence and Other Homestead Property

This millage will allow the school district to levy not more than the statutory rate of 18.0000 mills on all property except homestead property and other property exempt by law as required for the school district to continue to receive its full per pupil foundation allowance.

Shall the limitation on the amount of taxes which may be assessed against all taxable property, except principal residence and other homestead property as defined by law, in Clarenceville School District, Counties of Oakland and Wayne, State of Michigan, be increased to 19.0000 mills (\$19.00 on each \$1,000 of taxable value) for ten (10) years, calendar years 2026 to 2035, inclusive, to provide in part the funds to operate and maintain the school system? It is estimated that the revenue the school district will collect if the millage is approved and 18.0000 mills are levied in the 2026 calendar year will be approximately \$3,244,122 from the local taxes authorized in this proposal. Revenues will be disbursed to Clarenceville School District.

Clarenceville School District Building and Site Bond Proposal

Shall Clarenceville School District, Oakland and Wayne Counties, Michigan, borrow the sum of not to exceed Twenty-Nine Million Two Hundred Fifty Thousand Dollars (\$29,250,000) and issue its unlimited tax general obligation bonds therefore, for the purpose of defraying all or part of the cost of:

Erecting, remodeling, and equipping or reequipping school buildings, including structures, athletic fields, playgrounds, or other facilities, or parts of or additions to those facilities; furnishing or refurnishing new or remodeled school buildings; acquiring, preparing, developing, or improving sites, or parts of or additions to sites, for school buildings, including structures, athletic fields, playgrounds, or other facilities; acquiring, installing, or equipping or reequipping school buildings for technology?

The following is for informational purposes only:

Under current law, the estimated millage that will be levied for the proposed bonds in the year 2026, the first year that the levy will be authorized, is 3.68 mills (\$3.68 per \$1,000 of taxable valuation). The bonds may be issued in one or more series and may be outstanding for a maximum of twenty (20) years, exclusive of any refunding. The estimated simple average annual millage anticipated to be required to retire this bond debt is 3.36 mills (\$3.36 per \$1,000 of taxable valuation).

(Pursuant to State law, expenditures of bond proceeds must be audited, and the proceeds cannot be used for repair or maintenance costs, teacher, administrator or employee salaries, or other operating expenses.)

Randy Bruce -

Randy Bruce is a candidate for mayor, first elected to City Council in 2003 and re-elected four times for a total of 20 years on Council. He has also served as the mayor pro tem

for four terms.



Prior to City Council, he served on the Zoning Board of Appeals from 1995 to 2003, including two years as chairman. He has been a member of the Human Development Policy and Advocacy Committee of the National League of Cities, including as vice chair and chair. He has also been president of the Forestbrook Hills/Pebblebrook

Estates, Saratoga Farms, and Colony Park II Homeowners Associations.

Randy graduated from Wayne State University in Detroit, with B.S., M.A., and Ph.D. degrees, and is a licensed neuropsychologist and board-certified rehabilitation psychologist. He has been a business owner for over 35 years.

During Randy's time on Council, the City has been consistently named one of the safest and most financially stable cities in the State. Randy's many accomplishments while on Council include the building of the water tower, which saves over three million dollars per year for the citizens, passing of a rental inspection ordinance, and eliminating the special assessment districts for local road paying.

Randy wants to continue to work on redevelopment issues so that Farmington Hills remains a competitive city that continues to attract residents and businesses. Randy is a 39-year resident of the City, and he and his wife Jill are proud to live and work in Farmington Hills.
