EMERGENCY PREPAREDNESS COMMISSION TIP OF THE MONTH

The following Tip of the Month was read by Dennis Falkowski, Emergency Preparedness Commission Member:

**TIP OF THE MONTH
MAY 2017**

In the month of May, the Emergency Preparedness Commission reminds everyone to think summer, but be prepared for summer-related situations.

Summer in Farmington Hills is long anticipated and never seems to last long enough, so it is easy to forget that hyperthermia (high body temperature) can be life threatening and other heat emergencies can cause trauma and suffering. Yet heat illnesses are easily preventable by taking necessary precautions in hot weather.

Common causes of heat emergencies include high temperature and humidity, dehydration, prolonged or excessive exercise, excess clothing, alcohol use, and certain medications.

Heat emergencies can be prevented by wearing loose-fitting, lightweight clothing, resting frequently and seeking shade when possible, avoiding hot places, drinking adequate fluids, exercising gradually and increasing water intake.

**** Remember: *Never leave a child (or a pet) unattended in a vehicle.***

CITY MANAGER UPDATE

City Manager Boyer provided the following update:

- The DEA collected 156 pounds of prescription drugs during Drug Take-Back Day
- Hazardous Waste Collection Day reported approximately 2,100 cars
- The average home recycles 513 pounds per year, which is higher than national average
- Rouge River Rescue is scheduled for May 20, 2017 at Heritage Park from 9am-12pm

Councilmember Knol commented that Hazardous Waste Day is a joint event with other communities in the Authority and she would like to know the percentage of residents from each community that participated once that information is calculated.

City Manager Boyer stated that he would obtain that information and also get information out to residents about the hazardous waste days hosted by the other communities.

Fire Marshal Jason Olszewski stated that this Ordinance adopts the 2015 Edition of the International Fire Code to keep the City in line with the current Michigan Building Code recently adopted. The ordinance was introduced by Council at its last meeting.

NEW BUSINESS

CONSIDERATION OF ADOPTION OF A RESOLUTION TO JOIN THE OAKLAND COUNTY ONE STOP READY PROGRAM AND APPOINT KHALFANI STEPHENS AS THE LIAISON TO THE PROGRAM. CMR 5-17-45

Economic Development Director Khalfani Stephens explained that the resolution before Council would authorize the City of Farmington Hills to join Oakland County in their One-Stop Ready Program designed to teach communities about best practices regarding economic development. He stated that the classes offered would be at no cost to the communities.

WHEREAS, Oakland County Executive L. Brooks Patterson, established the One Stop Ready program to help local communities assess their strengths as an economic asset, follow their vision for the future, and empower leadership and staff to take action in order to be ready for economic and community development opportunities; and

WHEREAS, The One Stop Ready program is a community focused economic development program built upon self-evaluation, information sharing and outstanding customer service; and

WHEREAS, Farmington Hills commits to work together with county staff to respond quickly and efficiently to economic development opportunities that strengthen the tax base and improve the quality of life for residents, businesses and governments; and

WHEREAS, the county is encouraging communities to participate in the One Stop Ready program to collaborate with the county and fellow communities for the purpose of improving economic development readiness; and

WHEREAS, the City of Farmington Hills wishes to join the One Stop Ready program, will have all elected and appointed officials, and appropriate staff members sign a participation poster, and will designate an individual to be the local liaison to the One Stop Ready program; and

NOW THEREFORE BE IT RESOLVED THAT, the City Council of the City of Farmington Hills hereby accepts the joining of the Oakland County One Stop Ready program.

CONSIDERATION OF APPROVAL OF THE EXTENSION OF AGREEMENT PRICING FOR FACILITY EVALUATION TO CUNNINGHAM-LIMP PARTNERING WITH SIDOCK GROUP IN AN AMOUNT NOT TO EXCEED \$139,000.00. CMR 5-17-46

Director of Special Services Ellen Schnackel reported that the City has been discussing the possible use and renovation of Harrison High School with the Farmington Public Schools and she is present to ask for the extension of agreement for pricing for facility evaluation with Cunningham-Limp partnering with Sidock Group in an amount not to exceed \$139,000. She discussed the items included in the evaluation process and noted that it is estimated this phase would be completed within 90 days.

MOTION by Rich, support by Steckloff, that the City Council of Farmington Hills hereby authorizes the City Manager to issue a purchase order to Cunningham-Limp, partnering with the Sidock Group, in an amount not to exceed \$139,000 for Harrison High School Facility Evaluation and Phase 1 Construction Services.

CONSIDERATION OF APPROVAL OF THE INTRODUCTION OF AN ORDINANCE TO AMEND THE CODE OF THE CITY OF FARMINGTON HILLS, CHAPTER 2, "ADMINISTRATION," ARTICLE IV, "BOARDS, COMMISSIONS AND COUNCILS," FOR THE PURPOSE OF CREATING, UPDATING AND COORDINATING GOVERNING ORDINANCES FOR THE CITY'S EXISTING BOARDS AND COMMISSIONS AND INCLUDING THE ESTABLISHMENT OF A COMMUNITY HEALTH COMMISSION FOR THE CITY OF FARMINGTON HILLS.

Mayor Massey commented that Council started the process of reviewing their boards and commissions about 15 months ago but feels that the coordination will be well worth the effort put in if this Ordinance is introduced this evening.

Attorney Joppich explained that the current Code of Ordinances acknowledges 5 of the Boards and Commissions and the others were established by resolution, State law or some simply by a motion of Council. In reviewing the different boards and commissions, it became aware that there were many inconsistencies. City Council held at least 5 study sessions on this issue to review and discuss the various boards and commissions and develop the ordinance before them this evening. Attorney Joppich noted that the Ordinance now also identifies by reference the other boards and commissions that were approved by resolution, state law or some other method.

- Electrical and sign permits are to be obtained and have approved inspections
- The event shall comply with minimum Fire Prevention Code requirements
- The applicant will not block/restrict egress for the building or block/restrict fire lanes
- The applicant shall schedule a fire inspection prior to the beginning of the event
- The applicant has applied for a special liquor sales license from the Michigan Liquor Control Commission
- The alcohol will be sold by the Elders of the church and all identification will be checked prior to any sales
- No cash sales will be made in the tent area
- There will be live music at the event and applicant has been advised of the noise ordinance
- Ample on-site parking will be provided on site for attendees of the event
- The location shall be free of obstacles that would inhibit emergency police and fire response
- The applicant has requested no police assistance for this event

MOTION by Lerner, support by Rich, that the City Council of Farmington Hills hereby approves a Special Event Permit for Motor City Harley Davidson located at 24800 Haggerty Road, Farmington Hills, to hold the Harley Fest event on June 10th and 11th from 10am -10pm; subject to the following conditions:

- It is estimated that 3,000-4,000 people will attend during the two-day event between the hours of 10am and 10pm daily
- There will be alcohol sales on-site during this event and a special liquor license has been secured by the dealership
- Alcohol service will be in an enclosed outside area monitored by security personnel
- There will be ample parking provided to those in attendance. The MCHD parking lot will be used for motorcycle parking only and all other vehicles will use two parking lots on the west side of Haggerty
- There will be parking attendants in both parking lots to assist drivers
- There will be two Farmington Hills Police Officers at the north end of the parking lot assisting with pedestrian traffic crossing Haggerty Road
- There will be numerous vendor tents and activities in the parking lot during this event; emergency access and all fire lanes will be available
- There will be six bands playing during this event with the live music beginning at 1:00pm on both days.
- The stage and speakers will face east toward the dealership, with tents, semi-trailer displays and vendor displays between the stage and the building to act as a buffer for sound reflection coming off the building
- The Old Orchard Condominium Complex located to the west of the dealership in Novi will be notified of the event by a representative of MCHD 10 days prior to the event. The applicant will also work with the complex during the event to address any noise complaint issues
- MCHD will have 10-12 professional private security officers on-site for both days of the event
- MCHD has agreed to reimburse the City for the expense of 10 Farmington Hills Police Officers and two Sergeants at their overtime rate per the Police Chief's recommendation memo to the Clerk
- A signed and sealed certification for the stage must be provided
- An electrical permit shall be obtained from the Building Department and an inspection scheduled and approved prior to the opening of the event.
- The event shall comply with the minimum Fire Prevention Code requirements
- There will be no parking within 20' of the tent
- Tents must meet the NFPA 701 Standard and flame resistant label affixed to panels
- Egress from the facility shall not be blocked or restricted
- Fire lanes shall not be blocked or restricted
- MCHD must contact Fire Prevention to schedule an inspection prior to beginning the event
- The Farmington Hills Fire Department will be providing Medical Standby (1 Supervisor and

2 Paramedics) both days and the applicant has agreed to reimburse the city the cost for service as outlined in the Fire Department's recommendation memo to the Clerk

- The occupant load for the store area is 496 and the occupant load for the vacant space is 950. Neither area shall at any time exceed those amounts.
- If the vacant space is used, the locking hardware shall be removed for the doors
- Required insurance must be submitted prior to the event
- Required fees/bonds must be submitted prior to the event
